# **COMMUNITY-WIDE INITIATIVES**

Nashville has a goal to reduce GHG emissions, but there was not sufficient emissions data to determine if it is on track to meet this goal. Because of limited information, we were unable to determine Nashville's approach to community engagement or workforce development.

### **BUILDING POLICIES**

Nashville adopted the 2018 International Building Codes for commercial and residential properties. Nashville received a SolSmart Bronze designation in 2022 and allows solar use in all zones. The city offers a range of incentives and financing programs for efficiency actions.

Nashville has not recently updated its zoning code to facilitate location-efficient development, nor does the city require new developments to install EV charging stations. WeGo, the city's primary transit agency, offers free bus passes for homeless and housing-insecure individuals. Additionally, the city's bikeshare program offers free unlimited 2-hour trips for one week when residents check out a book from a public library.

### COMMUNITY ENERGY INFRASTRUCTURE

Nashville Electric Service and the Tennessee Valley Authority (TVA) offer the Home Uplift program to income-qualified participants. Nashville does not have a formal partnership with either utility. However, Nashville provided land at no cost to Nashville Electric Service for Music City Solar, a 2 MW community solar farm.



#### LOCAL GOVERNMENT OPERATIONS

Nashville's general services department administers an energy savings revolving loan fund program that uses savings to reinvest in future projects. More than 35 energy efficiency projects have been completed by the department since 2020 with data being tracked.
