It is my intent that these resources be used for the area of greatest need at the time they are received [OR identify a specific purpose you have discussed with ACEEE].

Beneficiary Designations

A beneficiary designation is another easy way to support ACEEE after your lifetime. Just name ACEEE as a beneficiary to receive assets from investments like retirement plans and life insurance policies that are not controlled by the terms of your will. You simply fill out a beneficiary designation form that is entirely separate from your will. Please use our legal name (American Council for an Energy-Efficient Economy) and Federal Tax ID Number (94-2711707). A beneficiary designation is not only an easy way to give, but it is also flexible. You can review and adjust beneficiary designations at any time.
