We will announce our selections in December 2021 and will provide an estimated 125-150 hours of ACEEE staff support services to each participating community over the period of January 2022 – June 2023. Selection Criteria

Applicants must meet these minimum requirements:

- Lead applicant (the one completing this application) should be a local government.
- Proposed technical assistance will support a policy or program designed to improve rental housing energy performance while preserving or expanding housing affordability.
- Local government applicant must include information about at least one community-based organization partner (CBO) that serves historically marginalized populations and a letter of support from that partner.
- Proposed technical assistance must contribute to an existing detailed policy or program work plan that is underway and on track to be completed or substantially advanced by June 2023.
- Technical assistance would supplement current and/or planned activities.

The most competitive applicants will also have the following characteristics:

- Planned or active rental energy performance policy and/or program development work aligns closely with actions steps outlined in ACEEE's policy guide *A New Lease on Energy*. These include analyzing the rental market, engaging the community, weighing possible rental energy efficiency policy options, and building rental efficiency partnerships to implement these initiatives
- Policy or program development has the potential to result in substantial energy and non-energy benefits (e.g. positive health outcomes, improved household finances, increased comfort) for renters.
- Local government applicant submits letters of support from more than one CBO partner.
- Local government applicant has a strong relationship with local housing department and other relevant rental housing market stakeholders.
- Policy and/or program that proposed technical assistance supports is replicable in other communities across the United States.
- Local government is taking an innovative approach to policy or program development.
