Quarterly highlights

Defending federal greenhouse gas vehicle standards



- ACEEE opposed a proposed EPA rule for the Reconsideration of 2009 Endangerment Finding and Greenhouse Gas Vehicle Standards, urging EPA to maintain strong GHG standards for light-, medium-, and heavy-duty vehicles to protect families, the economy, and the climate.
- Peter Huether, ACEEE senior research associate (pictured) and Daivie Ghosh, senior research analyst, gave testimony during the August EPA hearing for this proposed rule. ACEEE's [comments](#) argue that the standards are essential for lowering fuel costs and reducing pollution and that EPA's rationale for repeal is technically unsupported given ongoing efficiency gains and consumer demand for EVs and hybrids.

Supporting charging hubs for medium- and heavy-duty EVs



- Our [recent brief](#), informed by interviews with developers, examines the emerging practice of shared hubs for charging medium-and heavy-duty fleets with recommendations for utilities on how to plan for and encourage shared charging hub development.
- We provided [comments](#) to the Clean Corridor Coalition (a joint effort of Connecticut, Delaware, Maryland, and New Jersey) to inform development decisions along I-95 and [comments](#) to the New York Public Service Commission on proposed changes to the medium-and heavy-duty pilot program.

Guidance on community engagement for clean transportation project implementers



- ACEEE, supported by NYSERDA, authored a playbook ([download](#)) on creating a community engagement plan. The playbook, which draws from lessons learned from the project teams of New York's [Clean Transportation Prize Initiative](#), includes case studies, templates, a resource library, and a guide to conducting demographic analysis.

Lessons from utility pilots to expand EV charging access



- At our September [EV working group](#) meeting, Burlington Electric Department presented on pole-mounted charging and Southern California Edison introduced a forthcoming program on preloaded debit cards to subsidize the cost of public charging for income-qualified customers.
