One of the challenges of implementing recent federal funding effectively is ensuring that the investments reach the communities where they are needed most. Last month, ACEEE was selected by the U.S. Department of Transportation to be a Capacity Builder for the agency's <u>Thriving Communities</u> program. This funding will help ACEEE expand our work to help disadvantaged communities implement policies to create equitable, accessible, low-carbon transportation systems.

We've recently explored how to advance transportation system efficiency in a three-part blog post series diving into key topics such as how local governments can support <u>car-free modes of</u> <u>transportation</u>, how <u>land use policies</u> can advance low-carbon transportation, and how <u>recent</u> <u>federal funding</u> can help cities and states reimagine their transportation systems.

# **Efficiency Update**

 New York City Mayor Eric Adams recently released <u>PlaNYC: Getting Sustainability Done</u> to guide city leaders in taking a more comprehensive approach to climate change mitigation through interagency coordination and targeted stakeholder engagement. The plan is notable for including the city's first consumption-based greenhouse gas emissions Newsletter: Creating Equitable, Low-Carbon Transportation Systems

inventory, outlining the city's approach to climate budgeting, and laying out new and expanded strategies to reduce emissions in buildings and transportation, such as piloting the East Coast's first <u>low-emissions freight zones</u> in areas with the highest truck traffic and the worst public health outcomes.

 The City of Charlotte, North Carolina, and Duke Energy <u>announced</u> last month that they are partnering to launch a pilot program to help income-qualified households make energy efficiency upgrades. Duke Energy will invest about \$4 million for retrofits for about 500 households in the region, and Charlotte will provide up to \$1 million in American Rescue Plan Act funding to support home repairs needed before retrofits can occur.
